# John D. MacArthur Beach State Park Naturalist Internship



**John D. MacArthur Beach State Park** (MBSP) was established to protect a diverse and undisturbed subtropical coastal habitat from development. The Park is named for John D. MacArthur, whose generosity allowed the State of Florida to secure the land. Developed in part with funds donated by the John D. and Catherine T. MacArthur Foundation, the Park opened to the public in 1989.

In addition to protecting our natural heritage, John D. MacArthur Beach State Park is a model public-private partnership. Owned by the State of Florida, the staff and daily needs of the Park are funded by the State. Since its founding in 1990, the Friends organization has enriched and enhanced the Park by soliciting donations, seeking volunteers, raising funds, holding special events and operating a gift shop.

MBSP, Palm Beach County's only state park, is situated on a barrier island between the Atlantic Ocean and the Lake Worth Lagoon. The Park is made up of 438 acres of pristine coastal land and contains four different communities or habitats including seven species of plants and twenty-two species of animals on the endangered or threatened list. MacArthur Beach is truly an "Island in Time."

#### At MacArthur Beach State Park, we offer a Naturalist Internship that provides the opportunity to gain invaluable professional development and real-world experiences at MBSP.

#### The Naturalist Intern will gain experience in and develop an extensive knowledge of:

- Facilitating Science Summer Camp Programs
- Implementing Natural Science Education Programs
- Curriculum Writing and Development
- Volunteer Engagement, Public Speaking and Leadership
- Animal Care (educational exhibit fish, sea turtles, reptiles)
- Local Flora/Fauna of MBSP ecosystems
- Florida Park Service regulations, procedures and policies

#### Summary of Essential Position Functions:

All duties assigned by the Director of Education (DOE)

- 1. Reports to the Director of Education (DOE) for all duties assigned
- 2. Facilitates Science Summer Camp programs and ensures safety of all campers
- 3. Potential to assist in the development of publications, brochures, and registration materials
- 4. Other duties as needed

#### **Qualifications:**

- 1. Bachelor's Degree in environmental education, biology, environmental studies, ecology, or a related field required
- 2. Desire to teach children and adults in an outdoor setting. Prior field experience is a plus
- 3. Enthusiasm and dedication to learn and master curriculum
- 4. Excellent oral and written communication skills
- 5. Proficient computer skills: Microsoft Office programs including PowerPoint, Word, and Excel, etc.
- 6. Professional, well organized, and safety conscious
- 7. Team player who is also able to take on leadership roles and responsibilities
- 7. Ability to deal professionally, effectively, and courteously with other employees, volunteers and the public
- 8. Flexible in working hours and available for weekend and/or evening hours and special events
- 9. Adherence to all pre-internship procedures and policies:
- Personal and/or telephone interview with Park/Friends staff member
- Submission of required paperwork: Cover letter; Resume; References (3); Background screening

#### **Position Requirements:**

- 1. Must be able to lift and carry objects and materials up to 50 lbs.
- 2. Must be able to safely navigate natural unimproved terrain and ensure the safety of program participants.
- 3. Must know, respect, and follow safety policies and procedures given by the DOE
- 4. Must have the ability to communicate with students who have physical, mental, language, and behavioral issues; must be able to meet the learning needs of all students.
- 5. Must be able to consistently work in an outdoor setting with extreme weather conditions including but not limited to: hot, sunny, humid, rainy, and/or cold days.

#### Other:

- The statements contained in this position description reflect general details as necessary to describe the principal functions of this position, the level of knowledge and skill typically required, and the scope of responsibility. It should not be considered an all-inclusive listing of work requirements or functions.
- 2. Individuals may perform other duties as assigned, including work in other functional areas to ensure public safety and enjoyment and as part of the MacArthur Beach State Park team.

# Agency Responsibilities - MacArthur Beach State Park Will Provide:

- 1. Exposure to a variety of Science Summer Camp programs, activities, and lesson plans.
- 2. Opportunity to lead outdoor recreation activities such as hiking, snorkeling, swimming, and kayaking
- 3. Development of skills in various program settings and areas; to increase his/her knowledge of the organization and administration of designing, implementing, and evaluating programs and services.
- 4. Opportunity to acquire skills and in-depth knowledge to pursue specific natural science education, outdoor recreation, and resource management careers.
- 5. Experience in leadership and supervision of children ages 6 to 17.
- 6. Supervision by a professional staff person(s) during all aspects of internship training and performance.
- 7. An orientation to MBSP and the Friends of MacArthur Beach State Park; basic philosophy, procedures, and mission.
- 8. Free housing on Park property (when applicable).
- 9. Facilitation/instruction opportunities of the Summer Science Programs
- 10. Necessary uniforms and equipment.
- 11. Weekly meetings to answer questions and deal with concerns, and to map experience.
- 12. Observation of on-the-job performance to provide support, constructive suggestions, and interpretation of experience.
- 13. Completion and submission of an evaluation concerning performance.
- 14. Opportunity to integrate theory and practice in his/her professional education; to compare, evaluate, adapt, and adopt what is seen in practice to what has been previously experienced in theory.
- 15. Opportunity to gain an understanding and appreciation of the role, duties, and responsibilities of full-time professional staff for their future profession.

# Additional Skills and Training Available:

Naturalist Interns may receive training as nature center interpreters, animal care specialists, and nature walk interpreters, depending on time and interest. Interns may also participate in sea grass surveys, exotic plant removal, sea turtle nest surveys, turtle walks, habitat restoration, species surveys, research, and social media and web site posting.

#### **Compensation Information:**

Naturalist Interns are not employees of the Florida Park Service nor the Friends of MacArthur Beach State Park, Inc. Naturalist Interns are volunteers for MBSP, Florida Park Service.

Naturalist Interns can opt to receive a stipend of \$225/week for a full-time (40 hours a week) internship.

Limited housing is available, at no fee, for interns providing full time hours. If selected for housing, an intern will share a housing facility with other interns.

#### Naturalist Intern Housing:

Housing is a 32-foot, air conditioned mobile home located on Park property. The home has two bedrooms, one bathroom, kitchen/dining area and living room. The home is equipped with two refrigerators, cooking utensils and dishes.

Housing is located on the Lake Worth Lagoon (Intracoastal Waterway) with a dock. Interns will be able to use staff kayaks to explore our vast waterways and coastal community. Our location is close to grocery stores, restaurants, a Mall and other shopping/entertainment complexes. Although close in proximity, a vehicle is needed to get to these facilities.

Housing will be provided free-of-charge to qualified Naturalist Interns that work at least 35-40 hours a week. Failure to follow Housing Policies may result in the Student Intern losing housing privileges and/or losing their Internship. The following policies must be upheld:

- 1. An inventory of household items will be done prior to and upon end of Intern period. Interns will be responsible for replacement of items lost or damaged.
- 3. Interns will need to supply sheets, towels, cleaning supplies and other personal supplies.
- 4. Alcohol is not permitted for Interns under the age of 21; illegal drugs are not permitted.
- 5. Pets are not permitted.
- 6. Smoking is not permitted in Intern Housing or in any Park building/pavilion/porch area. Limited smoking areas are located in the central part of the Park.
- 7. Overnight and/or late night guests are not permitted; all guests must be off property by 11:00PM.
- 8. Intern Housing will be subject to inspections, without prior notice, by Park or Friends staff.
- 9. In case of inclement weather, ie. hurricanes, housing will not be provided. Interns must find shelter on their own accord.

#### Intern Dress Code:

- Clothing must fit correctly, not too tight or too loose.
- Closed-toe and closed-heel shoes
- Uniform shirt provided by Park
- Black shorts (mid-thigh length)
- No visible piercings, except for stud earrings for female staff, and no visible tattoos

If attire deemed unacceptable is worn, the supervisor will hold a private discussion with the intern and ask the intern to go home and change his/her attire immediately. Repeated violations will result in disciplinary action, up to and including termination.
